This statement was prepared on 18.06.2025.

The assessment of the website's compliance with accessibility requirements was carried out through an accessibility audit. The requirements of EN 301 549 and WCAG 2.2 Level A and AA were checked. Automated testing was performed using axe DevTools v4.103.8, WAVE Evaluation Tool v3.2.7.2, Siteimprove Accessibility Checker v2.0. Manual testing was performed using the assistive technology NVDA v2024.4.2.

The statement was last revised on 18. 06. 2025.
